**BILL 2024-18.** A Bill Relating to City Administration; Amending Section 2-8, SFCC 1987 to Change the Title From "Community Health and Safety Department" to "Health and Human Services Department"; Remove the Police Department and the Fire Department from that Section; and Create Two New Sections, 2-8.8 and 2-8.9, for the Police Department and Fire Department, Respectively.
