Request for Approval of a Grant Agreement with the US Department of Transportation Federal Transit Administration (FTA) for Section 5339 Funding for Public Transportation Capital Funding in the Total Amount of \$146,402. (Gabrielle Chavez, Transit Director of Administration; gnchavez@santafenm.gov)

1. Request for Approval of a Budget Amendment Resolution (BAR) in the Total Amount of \$172,240 with \$146,402 from the FTA Grant and \$25,838 in Required Matching Funds From the Transit Fund Balance to FY25 Transit Grant Revenue and Vehicles > 1.5.

BACKGROUND AND SUMMARY:

The City of Santa Fe's Transit Division has been awarded \$146,402 in Section 5339 Urbanized Area Capital Funding from the Federal Transit Administration (FTA), distributed through the New Mexico Department of Transportation. This funding is allocated based on a formula that considers population, population density, and service levels within the Urbanized Area. The award for Federal Fiscal Year 2017 will help fund the replacement of an aging cutaway bus that has exceeded its useful life. The total cost of the new vehicle is \$191,511, with the FTA funding providing partial reimbursement for this purchase.

Request to modify the Period of Performance End Date to 6/30/2026. The POP end date has changed from 03/30/2022 to 6/30/2026. Period of Performance End date expired 03/30/2022. Requesting POP be extended so that the City can move forward with the project, encumber funding and request eligible reimbursements within the POP dates.

Due to COVID-19 and staff vacancies Santa Fe Trails was unable to move the projects forward and this request was not submitted prior to the expiration of the POP end date.

Budget Revision #1

Change ALI to reflect the procurement of 1 cutaway bus instead of 2 vans for the Santa Fe Pickup service.

This grant application represents the FY2017 apportionment of small urban Section 5339 in the amount of \$146,402 to the City of Santa Fe. The Governor's Apportionment split letter from NMDOT is attached in Application Details. These funds will be used to purchase two Santa Fe Pick-up replacement 15 passenger vans. The local match funds will be provided by the City of Santa Fe through its 1/4 cent gross receipts tax dedicated to transit. The replacement vehicles will have a useful life of 4 years/100,000 miles.

Research and Development: This award does not include research and development activities.

Indirect Costs: This award does not include an indirect cost rate.

Suballocation Funds: Recipient organization is suballocated these apportioned funds and can apply for and receive these funds directly.
