Mayor and Members of the City Council:

In relation to Bill No. 2024-16:

A BILL
RELATED TO ETHICS AND CAMPAIGN REVIEW BOARD NOMINATIONS;
AMENDING SECTION 6-16.1 OF SFCC 1987 TO REMOVE THE REQUIREMENT THAT
THE FIRST JUDICIAL BAR ASSOCIATION SUBMIT A LIST OF EIGHT NOMINEES,
FROM WHICH THE FOUR ATTORNEY MEMBERS MUST BE APPOINTED, AND
REQUIRING THAT THE CITY CLERK SOLICIT NOMINATIONS FOR BOARD
MEMBERS FROM AT LEAST THREE LOCAL SOURCES.

I intend to propose the following amendment(s)

1. On page 1, line 16, *replace* “AT LEAST THREE” *with* “A VARIETY OF”.
2. On page 2, lines 4 through 7, *delete* “to the board from the First Judicial District Bar Association, the New Mexico board of bar commissioners who represent the geographic area including the city of Santa Fe, and the Santa Fe County league of women voters” and *replace* with the following:

as follows:

- i. Attorneys. The city clerk shall seek nominations to the board from groups including, but not limited to, the First Judicial District Bar Association, the New Mexico Board of Bar Commissioners who represent this geographic area including the city of Santa Fe, the New Mexico Hispanic Bar Association, the New Mexico Indian Bar Association, the New Mexico Black Lawyers Association, the New Mexico Women’s Bar Association, and the New Mexico Lesbian and Gay Lawyers Association.
- ii. Members at large. The city clerk shall seek nominations from the New Mexico Foundation for Open Government and the League of Women Voters of Santa Fe County, as well as by a public application process.
