Summary:

This bill would amend Section 6-16.1, SFCC 1987 to remove the requirement for the First Judicial Bar Association to submit a list of eight (8) attorneys licensed to practice in New Mexico to sit on the Ethics Campaign Review Board. Instead, the bill would require the City Clerk's Office to seek member nominations from the First Judicial District Bar Association, Representatives of the New Mexico Board of Bar Commissioners who represent Santa Fe, and the Santa Fe County League of Women Voters.

Consequences of Not Enacting Legislation:

If this legislation is not adopted, then the City's code would continue to require the First Judicial Bar Association to submit a list of eight (8) attorneys for the City of Santa Fe to select to sit on the Ethics and Campaign Review Board, despite the request by the Association that the ordinance not require it to make nominations.
