Mayor and Members of the City Council:

In relation to Resolution No. 2025-\_\_:

**IDENTIFYING CITY PROPERTY AT 2395 RICHARDS AVENUE AS A LOCATION FOR  
A MICRO COMMUNITY TO PROVIDE SHELTER AND SUPPORTIVE SERVICES FOR  
INDIVIDUALS EXPERIENCING HOMELESSNESS IN SANTA FE.**

I intend to propose the following amendment(s)

1. On page 2, line 23, *insert* “the following after “dispute resolution”:  
“; and  
**WHEREAS**, the Micro Community should be for family-use and, for this reason, the Mico Community should be a drug-free zone; and  
**WHEREAS**, the Governing Body would like regular updates about the activities at the Micro Community.”
2. On page 3, line 5, *insert* the following language:  
“**BE IT FURTHER RESOLVED** that the City shall prohibit alcohol and drugs, other than medication prescribed by a physician, to be used or present at the Micro Community, making the Micro Community a drug-free zone.  
**BE IT FURTHER RESOLVED** that the City Manager or City Manager designated City staff shall provide the Governing Body a bi-annual update regarding the Micro Community that may include information on services provided at the Micro Community, the number of residents transitioned into permanent housing, and any challenges experienced in operations of the Micro Community.  
**BE IT FURTHER RESOLVED** that for the Micro Community to continue operations after three (3) years, the Governing Body must reauthorize it.”
