

Summary:

The proposed bill amends Section 12-3 of SFCC 1987, pertaining to the public display of fireworks. If approved, the bill would eliminate the requirement of a resolution, allowing for permit approval for public display of fireworks after the City's Fire Chief recommends approval. The bill is consistent with the most recently adopted International Fire Code.

Departments Affected:

Community Health and Safety Department (Santa Fe Fire Department).

Consequences of Not Enacting Legislation:

If this legislation is not adopted, then Section 12-3 of SFCC 1987 will continue to conflict with the International Fire Code. In addition, the Governing Body would also still be required to pass a resolution relating to the public display of fireworks.

Conflict, Duplication, Companionship, or Relationship to Other Legislation:

None.

Performance and Administrative Implications:

The Bill clarifies removes requirements that previously were stated differently in the IFC and code and makes Governing Body approval of permits for public display easier by no longer requiring a resolution.
