A RESOLUTION

AUTHORIZING THE CONSUMPTION OF WINE DURING THE SANTA FE WINE AND CHILE FIESTA’S GRAND TASTING ON THE LAST SATURDAY OF SEPTEMBER, FOR THE YEARS 2025-2029, PURSUANT TO SUBSECTION 23-6.2(C) SFCC 1987.

WHEREAS, SFCC 1987, Section 23-6.2, governs the consumption of alcohol on City of Santa Fe (“City”) property; and

WHEREAS, for serving alcohol at City properties not specifically mentioned in SFCC 1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that specifies the event, date, hours, location, number of expected attendees, type of alcohol to be served, permits, and insurance, at least thirty (30) days prior to the event; and

WHEREAS, the Santa Fe Wine and Chile Fiesta is celebrating its 35th anniversary in 2025, an event which has become nationally recognized as a premier wine tasting event; and

WHEREAS, the Santa Fe Wine and Chile Fiesta has become a strong tourism economic generator for Santa Fe with an overall annual impact to Santa Fe in excess of \$7.7 million according to a 2024 Southwest Planning and Marketing economic impact analysis; and

WHEREAS, the Santa Fe Wine and Chile Fiesta’s Board of Directors desires to hold its

1 annual Grand Tasting on City property not mentioned in Section 23-6.2(A), in particular Fort
2 Marcy/Mager's Field; and

3 **WHEREAS**, Santa Fe Wine and Chile Fiesta plans to offer complimentary transportation
4 for attendees to and from the grand tasting; and

5 **WHEREAS**, the Santa Fe Wine and Chile Fiesta Board of Directors wishes to host the
6 event on the same City property for the next five years.

7 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
8 **CITY OF SANTA FE** that alcohol service during the Santa Fe Wine and Chile Fiesta Grand
9 Tasting, is hereby approved according to the following parameters:
