Summary:

The proposed resolution would authorize the consumption of beer, wine, cider, and mixed drinks that include liquor at the Santa Fe Wine and Chile Fiesta’s Chile Friday tasting event, every last Friday of September from 2025 through 2029. If approved, Chile Friday will be held at Fort Marcy Park/ Mager’s Field on September 26, 2025; September 25, 2026; September 24, 2027; September 29, 2025; and September 28, 2029, from 12:00 p.m to 3:00 p.m.. The request is pursuant to SFCC 1987, Section 23-6.2, which requires the Governing Body to adopt a Resolution to approve events on Santa Fe City property that are not specifically listed in Section 6.2(A) and SFCC 1987, Section 23-6.3(B)(7), which requires the Governing Body to adopt a Resolution to authorize a tasting event for events which offer liquor in mixed drinks.
