Summary:

The proposed resolution affirms the City of Santa Fe’s support for the continued federal stewardship of public lands in New Mexico and opposes any effort to sell, transfer, or reduced public lands protections. The resolution calls on the New Mexico Congressional Delegation to reject legislation that would negatively impact public lands and to support legislation that fully funds public lands, protects the Antiquities Act, and preserves national monuments. If approved, the City would send copies of the Resolution to members of the New Mexico Congressional Delegation, the Governor of New Mexico, and relevant federal land management agencies.
