A RESOLUTION

**AUTHORIZING THE SALE AND CONSUMPTION OF BEER AND WINE DURING THE
ROUTE 66 CENTENNIAL FESTIVAL 2025 CONCERT ON OCTOBER 11, 2025,
PURSUANT TO SUBSECTION 23-6.2(C) SFCC 1987.**

WHEREAS, SFCC 1987, Section 23-6.2, governs the consumption of alcohol on City property; and

WHEREAS, for serving alcohol at City properties not specifically mentioned in SFCC 1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that specifies the event, date, hours, location, number of expected attendees, type of alcohol to be served, permits, and insurance, at least thirty (30) days prior to the event; and

WHEREAS, the Santa Fe Railyard Community Cooperation is hosting the Route 66 Centennial Festival 2025 from October 10th through 12th; and

WHEREAS, the Santa Fe Railyard Community Cooperation wishes to serve beer and wine during the festival’s concert on Saturday, October 11th; and

WHEREAS, the Santa Fe Railyard Community Cooperation wishes to partner with As

1 Above So Below Distillery to provide beer and wine, promoting local businesses to the community.

2 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
3 **CITY OF SANTA FE** that alcohol service during the Route 66 Centennial Festival 2025 concert
4 is hereby approved according to the following parameters:

- 5 Event: Route 66 Centennial Festival 2025 concert.
- 6 Dates: October 11, 2025.
- 7 Hours: 5:00 p.m. – 10:00 p.m.
- 8 Location: Railyard Plaza.
- 9 Number of expected attendees: 1,000
- 10 Type of alcohol to be served: Beer and Wine.
- 11 Required Permits: Public Celebration Permit.
- 12 Required Insurance: Liquor Liability and General Liability insurance with
13 limits not less than \$2,000,000, per occurrence and in
14 aggregate, with the City of Santa Fe, its officials,
15 directors, employees, and agents as additional insureds on
16 a primary and noncontributory basis. As Above, So
17 Below shall provide the City with Certificates of
18 Insurance and applicable endorsements evidencing such
19 coverage.
