10 **A RESOLUTION**

11 **AUTHORIZING THE SALE AND CONSUMPTION OF BEER AND WINE DURING THE**
12 **ROUTE 66 CENTENNIAL FESTIVAL 2025 CONCERT ON OCTOBER 11, 2025,**
13 **PURSUANT TO SUBSECTION 23-6.2(C) SFCC 1987.**

15 **WHEREAS**, SFCC 1987, Section 23-6.2, governs the consumption of alcohol on City
16 property; and

17 **WHEREAS**, for serving alcohol at City properties not specifically mentioned in SFCC
18 1987, Section 23-6.2(A), the ordinance requires the Governing Body to approve a resolution that
19 specifies the event, date, hours, location, number of expected attendees, type of alcohol to be
20 served, permits, and insurance, at least thirty (30) days prior to the event; and

21 **WHEREAS**, the Santa Fe Railyard Community Cooperation is hosting the Route 66
22 Centennial Festival 2025 from October 10th through 12th; and

23 **WHEREAS**, the Santa Fe Railyard Community Cooperation wishes to serve beer and wine
24 during the festival’s concert on Saturday, October 11th; and

25 **WHEREAS**, the Santa Fe Railyard Community Cooperation wishes to partner with As

1 Above So Below Distillery to provide beer and wine, promoting local businesses to the community.

2 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
3 **CITY OF SANTA FE** that alcohol service during the Route 66 Centennial Festival 2025 concert
4 is hereby approved according to the following parameters:

5 Event: Route 66 Centennial Festival 2025 concert.

6 Dates: October 11, 2025.

7 Hours: ~~53~~:00 p.m. – ~~107~~:00 p.m.

8 Location: Railyard Plaza.

9 Number of expected attendees: 1,000

10 Type of alcohol to be served: Beer and Wine.

11 Required Permits: Public Celebration Permit.

12 Required Insurance: Liquor Liability and General Liability insurance with
13 limits not less than \$2,000,000, per occurrence and in
14 aggregate, with the City of Santa Fe, its officials,
15 directors, employees, and agents as additional insureds on
16 a primary and noncontributory basis. As Above, So
17 Below shall provide the City with Certificates of
18 Insurance and applicable endorsements evidencing such
19 coverage.
