12. On page 4, line 17, after Governing Body *insert* “for consideration”; and *strike* “, respectively”.
13. On page 4, line 21, *insert* “• Provide the Governing Body with a report on the status of goal achievements, objectives, and indicators for Fiscal Year 2025-2026.”
14. On page 4, lines 23-24, *strike* “and status updates on the Fiscal Year 2025-2026 goals”; and after “requests” *insert* “, including tradeoffs and choices made in the budget proposal development.”.
