Summary:

The proposed resolution would authorize the sale and consumption of beer and hard cider at the Santa Fe Adult Soccer League's annual Party on the Pitch Soccer Tournament to be held at the Municipal Recreation Complex's Soccer Fields on May 30, 2026. The request is pursuant to SFCC 1987, Section 23-6.2, which requires the Governing Body to adopt a Resolution for events on properties owned by the City of Santa Fe that are not specifically listed in Section 23-6.2(A).

Consequences of Not Enacting Legislation:

If this legislation is not adopted, then the Santa Fe Adult Soccer League will not be able to serve beer or hard cider as part of the Party on the Pitch Tournament.

In the past the Governing Body has approved the sale and consumption of beer at the 2022 tournament with Resolution No. 2022-20, the 2023 tournament with Resolution No. 2023-13, the 2024 tournament with Resolution No. 2024-16, and the 2025 tournament with Resolution No. 2025-18.

The Santa Fe Adult Soccer League is also required to obtain a public celebration permit for the event.
