- Your Comment: Board Members: I am writing to express my support for Santa Fe Christian's Special Use Permit at First Baptist Church. As a parent, local pastor, and resident of District 4, I am thrilled with what this small school is doing for our community. In addition to providing a quality education for its students, the school promotes community involvement and service. Most recently, the students prepared baskets of household goods for our senior citizens and handed them out at the Senior Center with the Mayor. Despite its small size and limited resources, the school has accommodated students with special needs and IEPs, and they distribute significant tuition assistance annually to families in need. The options for religious education in Santa Fe are extremely limited, and to my knowledge, Santa Fe Christian is the only

non-Catholic religious school we have. As the school continues their efforts to acquire their own property, First Baptist Church is the only facility in town equipped to house them. This extension will afford the school more time to raise additional funds and secure a more permanent location in the near future. It is my understanding that another school located at another church in the same area was given a permanent Special Use Permit, so this short extension seems more than reasonable given the brevity and minimal impact. Thank you for your favorable consideration of this request and your service to the City.
