Summary:

The bill would make a technical correction to Article I, "Definitions," in the Uniform Traffic Ordinance ("UTO"), Section 12-1-23.1, to relocate sub-paragraphs A through G and relocate them in Section 12-10-1.20, of Article X, "Mufflers – Prevention of Noise – Emission Control Devices", which contains regulations for mufflers. Paragraphs A through G are regulatory in nature, and they do not contain definitions. Their placement in a section devoted to definitions has caused confusion.
