Namoie Broyland. Spoke to issues on Cerrillos Road. We have failed. Our City is in a state of emergency. It is no longer feasible to continue operating in the way we are.

Hunter Redmond. Spoke in support of Pete's Place and their plans for a new resource center. Her firm is working on the plan.

Floyd Cable. Spoke about the pod community proposed on Richards and concerns about the site.

Chaplain Joe. Spoke in support of Pete's Place's plan for moving to a new location and more space and against bringing in a company from out of state.


