### **5. UPDATES**

#### **A. SANTA FE FILM OFFICE UPDATE**

Ms. LaBar-Tapia said we are a very busy office of two. Dark Winds season 4 is filming at Camelrock, there is a documentary on Rt. 66 coming in and several student films have been filming here. There are a few other independent films ramping up as

well. She has been sitting on a lot of panels, including the Economic Development Summit, the New Mexico Tourism Group and the Hospitality Group. The New Mexico Film and Media Conference will be on May 31<sup>st</sup> in Albuquerque. There will be a Liaison Summit the day before. She just went through the City budget process and presented her budget to the Councilors last week. The Mayor's State of the City Address will be Thursday night at 6:00 pm, at the Convention Center. Elisa Montoya is the new Rich Brown. She is the new Community Development Director. She will be in California the week of the 19<sup>th</sup>. If you have anyone you want her to meet with, reach out to her.

Chair Dillingham welcomed the new members to the Council and thanked the guests for attending.

Chair Dillingham said the next Above The Line event will be on June 26<sup>th</sup> at Los Golondrinas. The Governor's Council and the Santa Fe Film and Digital Media Council are touring Los Luceros on Friday. We are capped on the attendance. We can set up a second tour.

## **6. PRESENTATIONS**

### **A. SANTA FE STRATEGIC FILM FINANCE PROJECT**

Ms. Zimmerman said we are here today to talk about the tools available for projects, infrastructure small loans, micro-funding, finance tools, the consensus exercise and to make sure everyone is on the same page for priority initiatives.

Ms. Zimmerman introduced Toby Rittner, CEO.

Mr. Rittner gave a PowerPoint presentation regarding the Strategic Film Finance Project.

Ms. Zimmerman said we would like to open this up to a white board exercise with the Board for consensus around the top things you want to finance and barriers.

The first question is "What Do You Want to Finance". Responses were as follows:

- Pilot TV series, feature films, development funding for series, locally generated TV shows, art documentaries, student thesis projects, animation, small business support, infrastructure-not buildings, pod casts, back lot, documentaries, post production facilities, film festivals, post production training, way to mitigate capital risk with inventors - creative is a huge risk, script development, an incubator to help series or film development by cultivating our own for project development and production grants.

Anthony Emerson said he just started an animation company. He is trying to do language translations in Navajo. He is looking for financing to continue to do these projects.

The second question is “What Are the Barriers”. Responses were as follows:

- Small business loans in New Mexico don't seem to like film projects, dearth of producers, knowing how to raise money, understanding of the film process versus traditional loans, incentive programs are build around transitory revenue - not developing local funding for investment in the State, affordable housing to keep our youth here and small film makers are not clear on how to pitch and where.

Mr. Dennis said the heightened risk in investing in film is the start of the creative process of production while working on the story outline. The concern is when you are dealing with an idea, you try to get food on the table while you are writing.

Mr. Rittner said it is no different than when communities incubate investment ideas for commercial application, as an example. It is very hard to finance. You have to create an ecosystem.

Mr. Walukas said we want to intentionally bring together finances with the film community to demonstrate home grown grants. We are going to do events around this. He will put the contact information in the chat.

Chair Dillingham said we had 49 people on the call. We know Santa Fe has creative assets. How do we continue to connect. We need to develop a professional panel on this.

Mr. Rittner said you have to have a robust State program and Santa Fe has to have a robust local program. Most inventors want to get a State benefit as well.

Ms. Darrah said this is a whole different language for people in the film world. Is there anything that can be done to do education about small business loans as an option.

Mr. Rittner said you have to change that perspective. We can show success rates. It is changing the landscape. Bring inventors together to understand financing in the film industry. Build a lending environment. It is a mind set. It won't happen over night.

Michael Donnelly said he grew up in the food industry. Intellectual property is an investable commodity. It is the same thing as something not in the ground yet. Film is IP.

Chair Dillingham said we are running out of time for this meeting. Please complete the survey. She loves the participation today. We will continue this. Thank you Fawn and Toby. All of you, please keep coming back..
