5. UPDATES

A. SANTA FE FILM OFFICE

Ms. LaBar-Tapia said the Location Directory went live last month. The feedback has been very good. Reach out to Andrew or to her if you have anything to add or want to be on the other list for the provision of service. We went to a ribbon cutting at Nichols Dam. There are two great bodies of water there. If anyone needs bodies of water for projects let us know. They are open to filming. We are going to attend the South by Southwest Film Festival and are looking at attending Sundance. We are working with Economic Development on the Go Local program campaign. We are doing Go Local, Go Film. The details will be on our website. We will be sending out an email to Council members that you can pick up your swag.

Chair Dillingham asked if the Santa Film Office has a year end report that she

can include with the Council report.

Ms. LaBar-Tapia said we just did an in person report in November. She is happy to provide stats to you for your report.

6. PRESENTATIONS

A. INDY Q UPDATE

Ms. Darrah said Mr. Rogan is not here. She will contact him about rescheduling his presentation to the January meeting.

Ms. Darrah stated that Mr. Rogan is planning his next Indy Q in Santa Fe in January and they are planning to have one in Las Cruces as well. Film makers send in their short films or eight minute trailers of their movies, which are shown at the event. There is discussion and feedback given.

Mr. Lujan reviewed the list of activities and work IAIA has done, partnerships, projects, internships, student film opportunities and upcoming plans.

Dr. Stahmer reviewed the activities and work of the Stagecoach Foundation, partnerships, classes and education opportunities and future plans.

Dr. Wysong reviewed the educational opportunities and work of the Santa Fe Community College, the backlot status, recommendations from the group, needs, and Legislative requests.

GOVERNMENT AFFAIRS

Mr. Dennis reviewed the working group report including the background of the work of the group, how we got here, activity that the City is undertaking to help us, State activity, issues, needs, competitive incentives, the Film Loan Fund, incentive financing and requests.

A. SANTA FE FILM OFFICE

Ms. LaBar-Tapia said December was busy with multiple productions going on in town during the early part of the month. Dark Winds is in pre-production and getting ready to ramp up. A shout out to Vince Gilligan, who is a Santa Fe resident, and to the crew of Pluribus, which is the most watched show on Apple TV. He is the creator of Breaking Bad. Move Maker Magazine is coming out in a couple of weeks. Las Cruces, Albuquerque and Santa Fe are in the top 10 best places for movie making. We did an insert highlighting New Mexico in the magazine. If you want copies, let us know. We will let you know when they are available. We are going to Sundance in a couple of weeks and are going to South by Southwest. We will keep you posted on the details. After that, we will be attending the Association of Film Commissioners in LA. About half of you have not picked up your Santa Fe swag. Let us know about that. The Locations Guide continues to thrive.

6. PRESENTATIONS

A. NM FILM FOUNDATION UPDATE

Ms. Darrah said Mr. Rogan is not present. We wanted him to come talk about Indie Q. The next one is on January 9th at Jon Cocteau. She will put something about it in the chat.

Ms. La-Bar-Tapia said this is in partnership with our office. Andrew was

instrumental in bringing it to Santa Fe. It will be scheduled every other month.

A. STRATEGIC PLAN WORKING GROUP UPDATES

ABOVE THE LINE

Ms. Darrah said we are thinking the next event will be at Sky Theater. We want to be sure we are not holding too many of these events so they stay strong. We have had one Kombucha night. Another one is coming in February. We are thinking the next Above the Line event will be in March. If you have any ideas, please send them to her. The Opera Prop House has been suggested. Please put your information in the chat if you would like to join the working group.

EDUCATION

Dr. Stahmer said she has no updates yet after the holidays.

Mr. Ordaz said the United States Poet Laureate and Simon Ortiz will be doing readings in our gym tonight. He invited everyone to join them at 6:00 pm. It is free and open to the public.

Dr. Stahmer said we won a three year grant from AVID Learning Partners. We are creating a post production training program for AVID training and editing. We will be able to have 40 students in small groups of 5 throughout the year. She will put the link in the chat.

POST PRODUCTION

There was no report.

GOVERNMENT AFFAIRS

Mr. Dennis said we have had a couple of meetings. He met with the CEO of MFA. It sounds like the SIC is comfortable with loaning out \$150 million a year. The

original legislation will need to be modified. He has a meeting in the next weeks with partners to discuss further the 30 day session. The objective is to get a Legislative Sponsor to draft the legislation with staff to fit regulations. Staff knows best how to structure the legislation. The next step is to meet with Peter Wirth. The SIC needs a 6 ½% return. MFA needs 2% to cover overhead, and a letter of guarantee.

Chair Dillingham said we are also trying to prioritize New Mexico Above The Line in this if possible. We are going to try like heck to get as much as we can.

Ms. LaBar-Tapia said we have postponed the initiative for grants this year due to the situation with having to make up for lost Federal dollars. The amount of oil and gas revenue is down. We decided to wait for the next 60 day session to work on grants for film making. That makes more sense. We don't want to compete with the health and safety of residents programs.

Chair Dillingham said we are going to need help when we get our talking points together. The items on the 30 day session are only what is on the Governor's Call.

Mr. Tovarek asked can the Above The Line Working Group help.

Ms. Darrah said we initially felt so happy for what the Film Loan Fund could be. What is happening, is we have had to give on so many points just to get it going again. It has been a collaborative effort on what will work. We are looking at the Above The Line Working Group to something to promote what we can do.

Chair Dillingham said the Governor's Council is working on expanding existing grants so that is in play.

B. MATTERS FROM THE CHAIR

Chair Dillingham said she has expressed her thoughts during earlier discussion.

9. MATTERS FROM STAFF

Mr. Dalbor said he will put a link in the chat for our newsletter sign up.

Mr. Dalbor reviewed activities and events including the Native American Roundtable at the Incubator, the kick off of Go Local with the Guadalupe Walk, the work on the Department's year end report and the opening of the South Side Coordinator position.

Ms. Pura said Film and Media Day at the Legislature will be on February 17th. She is also doing a one-woman show the week of January 26th through the 25th.

Dezbaa said she is putting a link to a screening in the chat.

Brendon Widner. Mr. Widner said thank you for having these meetings. They are a fantastic resource.

Dan Mathis. Mr. Mathis said thank you for working on the Film Loan Fund. We are all in support of it. Let us know how we can help. He is part of the independent film community.

Tina Presley-Borek. Ms. Presley-Borek said we are excited about all of what you are doing in Santa Fe. She has Presley Talent, a Cast New Mexico initiative.

Aaron Jones. Mr. Jones said thank you for these meetings. They are very helpful.

Johanna Nelson joined the meeting and talked about Go Local - Go Different, small business support, crime prevention/crime mitigation grants and micro grants. She asked that interested parties reach out to Casey or her.
