##### **A. PRESENTATIONS BY FY 25-26 ART IS THE SOLUTION RECIPIENTS**

Ms. Johnson gave an overview of the Art Is The Solution program. The following recipients reported on their projects:

**JC Gonzo - New Mexico Burial** This project documents New Mexico cemeteries and their connection to history.

**Kemely Gomez & Carol Schrader**. This is a “table” project that includes a discussion of what it means to meet at a table, the experience and what takes place at a table.

**Ron Mier** This project is about Chimayo Weaving and includes implanted motifs of the region and the process used.

**Ehren Kee Natay & Leanna McClure - Echoes In Mosaic**”. This project reflects the creation of a mosaic mural.

**Leanna**. This project reflects workshops designed to develop voices and a sense of identity in the students.

**Sabrina Saleha**. This project is regarding profound loss and uplifting Native stories and building community.
