1 leadership and youth participation in civic activities; and

2 **WHEREAS**, there are numerous program and organizations for youth in Santa Fe; and

3 **WHEREAS**, a “network” is comprised of members who are representatives of their
4 respective organizations or campaigns, as to better serve a wider population of youth and provide
5 a stronger support systems for members; and

6 **WHEREAS**, the City of Santa Fe Youth Advisory Network will report to the governing
7 body once every three months on project progress and legislative recommendations ; and

8 **WHEREAS**, the City of Santa Fe Youth Advisory Network should work in the most
9 efficient and effective way for our cities youth; and

10 **WHEREAS**, the Governing Body wishes to formally create a network of young people
11 from the community of Santa Fe to provide input and suggestions and recommendations to the
12 Governing Body pertaining specifically to matters that affect the community’s youth.

13 **NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE**
14 **CITY OF SANTA FE** Resolution 2006-145 is repealed and replaced to restructure and rename the
15 Mayor’s Youth Advisory Board to the Mayor’s Youth Advisory Network.

16 **BE IT FURTHER RESOLVED** that the Governing Body hereby adopts the Provisions
17 of the Mayor’s Youth Advisory Network to include the membership and term sections as follows:

18 **Section 1.** The City of Santa Fe Youth Advisory Network is hereby formed.

19 **Section 2.** NAME: The committee shall be named The City of Santa Fe Youth
20 Advisory Network.

21 **Section 3.** PURPOSE: To provide, in a timely manner, input, suggestions, or
22 recommendations to the Governing Body of the City of Santa Fe pertaining to matters affecting
23 youth in the community.

24 **Section 4.** DUTIES AND RESPONSIBILITIES: The City of Santa Fe Youth
25 Advisory Network shall be responsible for providing future input, suggestions, or

1 recommendations to the Governing Body of the City of Santa Fe pertaining to issues that affect
2 youth in the community when deemed necessary and appropriate or upon request.

3 **Section 5.** MEMBERSHIP: The Mayor’s Youth Advisory Board shall consist of at
4 least 5 members, 25 years of age or younger, appointed by any community or educational group
5 operating in the city of Santa Fe. A non-voting City Council liaison shall also be appointed to the
6 Mayor’s Youth Advisory Network and will act as parliamentarian and administrative support. A
7 non-voting staff person will be assigned to help run meetings and provide additional support.

8 **Section 6.** TERMS: There are not term limits for members, however, after three
9 consecutive unexcused absences or failure to participate in at least governing body report with a 12
10 month period, a committee member shall automatically be removed by the chair.

11 **Section 7.** PROCEDURES: The committee shall elect the chair and the vice chair,
12 organize and adopt administrative rules and procedures necessary to accomplish its purpose.
