Procedures for Early Neighborhood Notification Meeting

1. ENN Name
 - a. Henry Lynch Road Reconstruction and Roundabout Project
2. Project Address
 - a. Henry Lynch Road between Rufina St and Agua Fria St
3. Description
 - a. The proposed project will reconstruct Henry Lynch Road from Rufina Street to Agua Fria Street to address critical safety deficiencies, improve multimodal access, and enhance overall corridor functionality. Improvements include construction of two 10-foot travel lanes designed to calm traffic while maintaining efficient vehicle movement, ADA-compliant sidewalks on both sides of the roadway to ensure accessibility for all users, and separated bicycle lanes to provide safe and dedicated space for cyclists. The project will also install curb and gutter and implement comprehensive stormwater drainage improvements to mitigate flooding, reduce roadway deterioration, and increase infrastructure resilience during storm events. A roundabout will be constructed at the intersection of Agua Fria Street and Henry Lynch Road to improve traffic operations and significantly reduce vehicle conflict points. The roundabout will enhance safety for motorists, pedestrians, and cyclists while supporting long-term operational efficiency. Collectively, these improvements will transform the corridor into a safer, multimodal facility that supports connectivity to surrounding neighborhoods, schools, and businesses. The project advances state and regional transportation goals by improving mobility, increasing roadway safety, enhancing ADA compliance, supporting economic vitality, and investing in sustainable, resilient infrastructure.

The City of Santa Fe and Santa Fe County, in cooperation with the New Mexico Department of Transportation, will host a public open-house meeting to present information about the Henry Lynch Road Reconstruction and Agua Fria Roundabout Project and to provide an opportunity for the public to ask questions and share comments. The project is currently in the Pre-Final Design Phase (90% complete).

The purpose of the Project is to provide safe and equal access for all road users, especially vulnerable populations, by enhancing multimodal mobility and connectivity. Improvements will also include upgraded stormwater drainage to help prevent seasonal flooding.

The meeting will allow the public to speak directly with project representatives, ask questions, and provide feedback in an interactive format. Additional public input (comments and questions) will be accepted after the meeting through May 30th, 2026.
