#### F. INITIATIVES AND ACTIONS

##### 1. Food and Agricultural and Water Initiative Priorities - review \*

Peter said that we've done the resolutions which have been approved. We need to follow up to make sure that the lobbyists have this at the top of their list as well as doing other kinds of followup.

##### 2. Legislative Update- Pam Roy SFFPC Coordinator and Hvtce Miller, Santa Fe County, Intergovernmental Outreach Coordinator

Pam went over the priorities/initiatives that the NM Food & Ag Policy Council has put together. James confirmed that the NM Grown program has really been working for SF County. They received \$32,000 this year and are just getting started. Pam talked about how the NM Grown program works - how it supports institutions and farmers and ranchers. She also went over other programs that support food and farming, particularly the issues around water. The NM Food & Ag Policy Council has created a statement around water. There will also be a bill this session for pollinators.

Some of the agencies have the NM Grown program in their budget. Some programs are contingent on federal funding and there is a need to stabilize the funding. Other programs will help build out nutrition support and also provide support for farmers to implement capability-building. The Approved Supplier program is an important cornerstone of this work.

Peter had questions about how the farm bill continuation did not fund certain programs. Pam said that we will probably not have a farm bill in the near future, but we continue to work with national coalitions and our congressional delegates to make progress. There are many new legislators at both the state and federal level who will need to learn about the value of these programs.

The food assistance programs partially rely on funding from the Inflation Reduction Act, which ends this July. This type of food assistance is critical. One of the things that we have prioritized in our advocacy is that farmers/ranchers should get a fair price for their products.

We discussed having the SFFPC sign on to the NMFAPC's legislative priorities and then we can get that information out.

Hvtce said that the branding is important for the materials so we should have the City and County logos on the materials.

Pam and Helen went over resources that we have for advocacy, meetings and events.
